Freer called the meeting at 3:02 pm.

ATI Coordination Initiatives

Fundell stated accessibility technology initiative is a CSU wide mandate, ensuring accessibility is proactive in procurement communication, technology, and student instruction. The accessibility policy has been updated.

The annual Campus Accessibility Report Technology (CART) was submitted to the CO during the first week of November 2020.

Fundell stated the ATI audit is still underway, but just about finished. Fundell will provide official findings in the next meeting.

Executive Order 1111

Freer stated there was one preliminary finding meeting so far for the EO 1111 Advisory Services Audit. In early December, they will have full findings of the audit and report.

Issues from the Floor

Sorenson reviewed the phases of the accessibility project that is funded by the CO. The first phase, and the highest priority, is to access and accessibility to buildings for students, staff, faculty, and the public. Facilities has installed handrails that are compliant over the last several months.

Second phase will be the installation of a crosswalk from parking lot C. Additionally, the walking path from bookstore and children's center is going to be upgraded with new concrete. The project will be completed by June 2021.

Third phase will include the Pfau library classrooms that are under construction. Furniture is being replaced with accessible seating. Student counts are being reduced to provide walkways and movability in and out of classrooms.

Facilities has provided huge renovation to Pfau library elevators. The work is already underway. PA, FOB, Jack brown, HPE, VA, UH, PDC IWA, project completed in January 2021.

Daniels informed the ACLU alleged that all community colleges and universities are supposed to have voter registration sites and that the campus should retain students' voter registration for at least two years. CSUSB has not received the letter from ACLU. ACLU claimed SSD offices were creating barriers for students to register.

Moran stated CSUSB was in the top 20 out of 100 schools that registered the most students to vote even in a virtual world.

Freer informed the old gymnasium was converted into a polling place for one week. CSUSB now has a ballot drop box near the flagpole as well.

Freer ended the meeting at 3:50 pm.
