**Human Sexuality, 10 CE**

The study of physiological-psychological and social-cultural variables associated with sexual identity, sexual behaviour or sexual disorders.

**Alcoholism and Chemical Substance Abuse 15 CE**

The definition of alcoholism and other chemical dependency, and the evaluation of the abuser. Medical aspects of alcoholism and other chemical dependency. Current theories of the etiology of substance abuse. The role of persons and systems that support or compound the abuse. Major treatment approaches to alcoholism and chemical dependency. Legal aspects of substance abuse. Knowledge of certain populations at risk with regard to substance abuse. Community resources offering assessment, treatment and follow-up for the abuser and family. The process of referring affected persons. Education concerning the prevention of substance abuse. *\*(There is an additional \$10.00 for copyright course workbook)*

**Spousal or Partner Abuse Assessment 15 CE**

Spousal or partner abuse assessment, detection, and intervention strategies, including knowledge of community resources, cultural factors, and same gender abuse dynamics.

**Child Abuse Assessment 7 CE**

Include the study of the assessment and method of reporting of sexual assault, neglect, severe neglect, general neglect, willful cruelty or unjustifiable punishment, corporal punishment or injury, and abuse in out-of-home care. The training shall also include physical and behavioral indicators of abuse, crisis counseling techniques, community resources, rights and responsibilities of reporting, consequences of failure to report, caring for a child's needs after a report is made, sensitivity to previously abused children and adults, and implications and methods of treatment for children and adults.

### **California Law and Professional Ethics 18 CE**

California law and professional ethics that includes, but is not limited to: Instruction in advertising, Scope of practice, Scope of competence, Treatment of minors, Confidentiality, Dangerous clients, Psychotherapist-client privilege, Record keeping, Client access to records, The Health Insurance Portability and Accountability Act, Dual relationships, Child abuse, Elder and dependent adult abuse, Online therapy, Insurance reimbursement, Civil liability, Disciplinary actions and unprofessional conduct, Ethics complaints and ethical standards, Termination of therapy, Standards of care, Relevant family law, Therapist disclosures to clients

### **Aging and Long Term Care 10 CE**

### **Crisis or Trauma Counseling 15 CE**
