The board participated in a group activity to discuss each goal and how the board members could contribute to each goal.

Provost Rafik Mohamed along with Tanner Carollo, Director of Institutional Research & Analytics and Chief Data Officer, presented on enrollment and student support. Topics included CSUSB enrollment trends, the effects of admissions melt, new initiatives to attract students, and strategies for outreach and proactive advising.

Elevator Pitch

Robert Tenczar, Associate Vice President of Strategic Communications, presented to the board on key elements that are included in an elevator pitch. He presented CSUSB's notable accomplishments to the board and led the board in a group activity to evaluate which CSUSB accomplishments resonated with the board. Board members turned in their recommendations and Tenczar will review and disseminate a Foundation board elevator pitch to board members at the September board meeting.
