Welcome and Call to Order

Chair William Stevenson called the Board of Directors meeting to order at 3:35 p.m.

President Morales provided an update on enrollment trends and highlighted targeted initiatives aimed at enhancing Black Student Success. He also shared the excitement and success of the Spring 2024 Commencement, which featured Ellen Weisser and Dia Poole as the honorary doctorate recipient. Additionally, President Morales discussed ongoing strategies from the Division of Strategic Enrollment to support student enrollment and retention.

MSPA Program Update

Sonia Otte, Founding Director of the MSPA program, provided the board with an update on the program's progress. She discussed the program's mission and vision, along with an overview of CSUSB's educational approach. The board received handouts detailing admission and scholarship opportunities.

Board Retreat Strategic Priorities

Monica Alejandre recapped the presentation made at the March board retreat by Dr. Nicole Dabbs on CSUSB's strategic plan, and Provost Mohamed discussed student success priorities. The board discussed which priorities resonated with them and how they could support these through philanthropy, advocacy, and budget support.

Alejandre thanked the board for their discussion on the priorities and looks forward to working with board members on the strategic plan for the board.

Committee Report – Investment Committee

Gary McBride, Chair of the Investment Committee, presented the investment committee report. As of March 31, the endowment was valued at \$57 million, with a 4.8% quarterly return and a 14% return over the past year. McBride also provided an update on the work North Pier has been doing for the Foundation in getting them ready for an RFP process.

Director's Report

On behalf of Executive Director Robert Nava, Monica Alejandre presented the Director's report. She updated the board on new staff within University Advancement, including the introduction of Ray Watts, the new Associate Vice President of Philanthropic Giving, and invited him to share some background about himself. Alejandre also asked Zack Tucker to provide a brief update on the fundraising campaign. Additionally, she shared details about an AGB article authored by board director Lou Monville and Robert Nava, encouraging the board to read it as the article discusses the role of advocacy and community relations for Foundation boards.

Endowment Management Fee

Monica Alejandre presented a proposal to the board to raise the endowment management fee from 0.75% to 1%, in anticipation of a 7% annual increase in operations costs. Alejandre shared projections demonstrating the impact of different fee rates on investment income and operating expenses and compared the proposed increase to national and CSU benchmarks for endowment management fees. The board engaged in a detailed discussion about the implications of the fee increase, particularly its impact on scholarship support.

The board approved the increase of the management fee from 0.75% to 1%. (Jackson/Srinivas) **Motion Passed**
