AVAILABILITY, LOCATION, AND METHODS TO SUMMON LAW ENFORCEMENT ASSISTANCE

Availability and Location of Law Enforcement Assistance

The California State University, San Bernardino Police Department (University Police Department "UPD") is located at 5500 University Parkway, San Bernardino, CA and provides police services 24 hours a day to our community. Police Dispatch can be reached directly 24 hours a day by phone at (909) 537-5165 or (909) 537-7777.

Riverside Sheriff Department, Palm Desert Station, has primary jurisdiction for the safety and security of the Palm Desert Campus (PDC). Riverside Sheriff Department, Palm Desert Station, is located at 73705 Gerald Ford Drive, Palm Desert, CA and can be reached 24 hours a day at (760) 836-1600.

Enforcement and Arrest Authority

The police officers of CSU San Bernardino have state-wide police authority and jurisdiction per Penal Code section 830.2 and Education Code section 89560 and are vested with law enforcement powers and responsibilities identical to the local police or sheriff departments in your home community.

Crime Reporting

The entire campus community is strongly encouraged to report any and all known or suspected incidents of criminal activity or Hate Crime or Hate Incidents on campus to UPD as soon as possible. When calling the University Police Department, always:

- Give your name, telephone number, and location.
- Give clear and accurate information.
- Be prepared to supply suspect and vehicle description, and direction of travel; and
- DON'T HANG UP! Follow the instructions of the dispatcher.

Students residing in on-campus housing may also report crimes to the on-duty Resident Advisor who will ensure the immediate notification to UPD.

The campus Emergency Alert Hotline at (909) 537-5999 is a recorded message with information related to immediate emergencies that may be happening on campus. The message may contain information related to building closures, employee/work status information, and campus closures.

Emergency Blue Light Call Stations

The 9-1-1 emergency telephone system will put you in contact with emergency personnel for any emergency or non-emergency need, 24 hours a day. There are over 60 emergency call stations located throughout the CSU San Bernardino campus, including residential housing, and five (5) at the Palm Desert Campus. There are over 500 surveillance cameras located throughout the two campuses, with over 440 on the San Bernardino campus and over 50 between PDC and the PDC facilities.

SPECIAL SAFEGUARDS FOR FACILITIES OR ACTIVITIES

Security of and Access to Campus Facilities

Most campus facilities are key-accessed, and most are open daily for scheduled campus community use. The Housing and Residential Education Buildings are accessible by card access only. Campus key control and distribution is a function of Facilities Services. To provide for the security of campus facilities, the University Police Department enforces Educational Code section 89031 & CSUSB Housing Policies. Campus facility access may be revoked per Penal Code section 626.

Security Considerations Used in Maintenance of Campus Facilities

Regular inspections and security surveys of campus indoor/outdoor lighting, shrubbery, and walkways are conducted. The University participates in Crime Prevention through Environmental Design concepts for planning and improvement on campus.

Special Event Safety Planning

Preparation for large events on campus involves the creation of Event Action Plans according to the Standardized Emergency Management System and in collaboration with mutual aid agencies and contracted safety personnel.

ACTIONS IN THE LAST 18 MONTHS TO INCREASE SAFETY

Deployment of new "CSUSB Safe" public safety app that provides 1-button 911 call/access to on-campus UPD Dispatchers, enhanced communication tools to contact and share information with the University Police Department/Dispatch, contact information for off-campus law enforcement partner agencies (San Bernardino Police Dept., San Bernardino Co. Sheriff's Dept.), a virtual escort function, and quick access to campus support resources including:

- Student Health Center
- Counseling & Psychological Services
- Domestic Violence Resources
- Addiction/Recovery Services
- Veterans Resources and more

Emergency Management was the recipient of a Vital and Expanded Technologies Initiative (VETI) grant (\$61,000) to fund the purchase and deployment of 20 new Automated External Defibrillators (AEDs) across campus. These new units will serve to increase awareness of, and access to, a valuable life-saving device during a cardiac-related medical emergency.

Provided "How to Prepare at Home" education opportunities for faculty, staff, and students to learn how to get on the path of individual and family preparedness.

Updated three campus policies: Campus Closure Procedures, Campus Evacuation Procedures, and Emergency Communication Notification Procedures. These policies provide guidance and direction for staff members responsible for responding to emergencies and assist in managing the expectations of the community during emergency situations on campus.

CHANGES IN SAFETY PRECAUTIONS DURING THE NEXT 24 MONTHS

- Efforts to enhance the recruitment, training, and equipping of Campus Area, Building, and Floor Marshals will continue. These volunteers play a crucial role in carrying out evacuation and accountability functions when needed during emergencies.
- Regular building evacuation drills will be conducted across the CSUSB campus to provide Marshal Program participants with opportunities to apply and refine their skills in real-world scenarios.
- Collaborative efforts with campus departments will be ongoing to support the completion and regular updating of Emergency Action Plans and Business Continuity Plans.
- The distribution of Naloxone (NARCAN®), a nasal spray for opioid overdose treatment, will be expanded to include all UPD Officers, Campus Safety Officers (CSOs), and Community Service Specialists (CSSs), ensuring broader access to this lifesaving resource.
- “Stop the Bleed” training will be offered to UPD, Facilities, and other campus departments and personnel, helping them develop the skills needed to quickly identify and respond to life-threatening bleeding in emergency situations, ultimately making a significant impact on survival outcomes.
- The inventory and cataloging of Emergency Management and Business Continuity response supplies, equipment, and resources will be completed, alongside the development of a needs assessment and budgeting proposal to address any identified gaps in the program.
- The Emergency Management and Business Continuity website will be consistently updated to ensure it offers up-to-date, accessible information, resources, and relevant links to support campus safety and preparedness. The campus-wide Emergency Operations Plan (EOP), along with other emergency plans and drill information, will be made available for easy access through the website.

RECORDS OF ON-CAMPUS CRIME

California Education Code 67380(a)(1)(A)

California State University campuses are required by California Education Code 67380(a)(1)(A) to compile records of all occurrences reported to campus police, campus security personnel, or campus safety authorities of, and arrests for, crimes that are committed on campus and that involve violence, hate violence, theft, destruction of property, illegal drugs, or alcohol intoxication, and to make this information available within two business days if requested by students, prospective students, employees, or the media.
