ED Felix deferred his time to Ms. Puccinelli Ms. Puccinelli discussed a new Employee Reference Policy that will be presented to the Board for approval. The policy differentiates between SMSU-provided recommendations and personal references given by employees. Official letters of recommendation must go through Jenny Puccinelli, HR Manager to ensure the employee's record is reviewed for issues such as write-ups or termination for cause. For employment verifications, only job titles, dates of employment, and job duties will be confirmed unless a release is provided. Personal references must clearly indicate that the employee is speaking in a personal capacity and not on behalf of SMSU.

PC 15/25 Review financial impact of health benefits for 24-25 fiscal year (Discussion, Najera-Neri)

M/S Felix/Agudo motion to open PC 15/25 Review financial impact of health benefits for 24-25 fiscal year.

The Personnel Committee discussed the 2024 and 2025 employee health benefits and related premium increases. It was noted that premiums will rise across all categories in 2025, with a 7.8% overall increase. Most employees use Kaiser or Blue Shield plans, with very few paying out-of-pocket costs due to their plan selection. The committee highlighted that SMSU's health premiums remain lower than campus rates due to their CalPERS package, and employees are notified of premium changes during open enrollment, allowing them to adjust plans as needed.
